Overview

ConvergeOne, Inc. and its affiliates ("C1") are committed to being leaders in environmental sustainability. Our future—and that of our customers—depends on the health of the environments, communities, and economies in which we operate. We recognize our responsibility to assess and mitigate the environmental impacts of our operations and decisions.

Policy Commitment

We aim to minimize our environmental footprint through specific, measurable actions. Our commitments include:

- o Establishing and maintaining this Environmental Policy.
- Setting specific quantitative targets, including:
 - o A 15% reduction in energy consumption by 2025, based on 2021 levels.
 - Decreasing our physical US footprint 48% by 2025 based on 2021 by (291K square feet) and <u>decreasing our carbon footprint</u> by 10%.
- Implementing a structured process for tracking and documenting GHG emissions and energy usage, with transparent annual reporting on progress to stakeholders by 2026.
- Defining building and office standards that promote sustainability, including energy-efficient technologies and sustainable materials.
- Establishing daily practices aimed at reducing office carbon footprints, including the adoption of recycling programs and sustainable procurement policies.
- Providing comprehensive environmental awareness training for employees, focusing on specific actions they can take to support our sustainability goals.
- Pursuing relevant environmental sustainability certifications and initiatives, with a commitment to continuous improvement.

As a testimony to our above commitment:

- In 2021, 2022, and 2023, C1 received a bronze rating from EcoVadis, the leading platform for environmental, social, and ethical performance ratings for global supply chains.

Scope

 - Coordinating training and awareness programs.
 - Facilitating communication of environmental initiatives both internally and externally.
- **Site Ambassadors:** Each location will have a contact that will be responsible for assisting with:
 - o Implementing and maintaining environmental practices at the local level.
 - Identifying local environmental risks and opportunities.

Mission Statement

C1 is dedicated to protecting the environment, ensuring the health and safety of our employees, and supporting the communities we serve. We strive for continuous improvement in our operations by conserving energy, water, and natural resources; reducing waste generation; recycling; and minimizing the use of toxic materials. Major Environmental Issues

C1 will focus on the following key environmental issues, with specific strategies for each:

1. Climate Change:

 Implement measures to reduce GHG emissions and enhance energy efficiency across all operations.

2. Waste Management:

Establish programs for waste reduction, recycling, and composting.

3. Resource Conservation:

 Optimize the use of natural resources, including energy, water, and materials, ensuring sustainable practices in all operations.



4. Pollution Prevention:

o Identify and minimize pollutants through enhanced operational practices and compliance with all environmental laws and regulations.

Review Mechanism

This policy will be reviewed annually by the ESG Council. The review will include:

- Assessment of progress against quantitative objectives.
- Evaluation of implementation effectiveness at all levels of the organization.
- Identification of areas for improvement and adjustment of targets as needed.
